Thank you for your FOI request received by the FOI office, requesting information on NHS Supply Chain utilisation of automation in managing supply chain Inventory. The definition of automation includes robotics and artificial intelligence. Inventory may be defined as the stock of items stored by an organisation for the meeting of customer's needs.

Your request has been handled as a request for information under the Freedom of Information Act 2000 and we are able to provide a reply to your request. Supply Chain Coordination Limited (SCCL) confirms it does hold the information on utilisation of automation in managing supply chain Inventory.

SCCLs responses to your questions are below.

Q1. Is artificial intelligence or robotics used anywhere within the organisation's supply chain?

No. At present AI or robotics is not being used to manage supply chain inventory within NHS Supply Chain.

NHS Supply Chain has a continuous improvement programme that encompasses inventory management and part of this programme includes the review of stockholding and stock management policy, to ensure the best support to the NHS can be provided.
