Thank you for your FOI request received by the FOI office for the following information:

The quantity of single use anaesthetic masks for a 12 month period, outside the pandemic if possible, as well as the quantity of reusable anaesthetic masks in the same 12 month period, with number of reuses against them.

Your request has been handled as a request for information under the Freedom of Information Act 2000 and SCCL confirm that we are able to provide a response.

For the first part of the question: quantity of single use anaesthetic masks for a 12 month period, data has been taken from the full financial year of 2022-2023. The total sum of Single Use Anaesthetic facemasks for 22/23 was 1,787,950.

For the second part of the question: quantity of reusable anaesthetic masks in the same 12 month period, with number of reuses against them. The total sum of Reusable Anaesthetic facemasks for the same period was 12,296.

We do not have the details of the number of reuses recommended by the manufacturer. The below list is the suppliers we have on framework which have reusable facemasks listed through NHS Supply Chain:
