Thank you for your FOI request received by the FOI office for the following information about the Single Use Personal Protective Equipment and Medical Consumables framework agreement (2021/S 000-016429):

1. Lot 1 - Single Use Sterile Surgical Gowns: a) names of contracted supplier companies on this tender; b) list of countries the NHS Supply Chain sources products in this lot from (i.e. the countries they are manufactured in).
2. Lot 2 - Single Use Sterile Non-Surgical Gowns: a) names of contracted supplier companies on this tender; b) list of countries the NHS sources products in this lot from.
3. Lot 7 - Single Use Protective Wear: a) names of contracted supplier companies of aprons on this tender; b) countries the NHS sources aprons in this lot from.
4. Face masks: a) names of current contracted supplier companies of face masks; b) countries the NHS sources face masks from.
