"Please can you provide a full copy of the SCCL spend data (above £25,000) in excel format for storage costs related to PPE, Covid-19 tests and all other Covid-19-related items. If this breakdown is not possible, please provide the SCCL spend data for general storage costs.

Please provide spend data covering the period 01 October 2022 to the present day. Please include ALL payments made by SCCL for these storage costs above £25k."

Your request has been handled as a request for information under the Freedom of Information Act 2000 and SCCL are able to provide a response:

NHS Supply Chain operates a number of warehouses across the country for the distribution of medical devices and consumables to the NHS in England and Wales. Included within this network would normally be some elements of PPE that are used by the NHS in England, however at this point in time the vast majority of PPE is being provided free of charge to the NHS by the Department of Health and Social Care. SCCL is acting as agent to the DHSC to supply PPE. Therefore, there are minimal volumes of PPE in our network with no specific storage costs.

The DHSC provides updates to the Public Accounts Committee which include storage costs for PPE stock owned by the DHSC and these can be found here:
