Thank you for your FOI request received by the FOI office for the following information. Your request has been handled as a request for information under the Freedom of Information Act 2000 and SCCL are able to provide a response in blue below:

- Under the Freedom of Information Act, I would like to request the following information relating to Renal Replacement Therapies Services, Technologies, and Consumables Reference: 2023/S 000-017117.
- 1. Framework prices for goods and services included in Lots 1.3 and 3.0 Tender pricing provided for the framework for Lot 1.3 and 3 was based on products or specific scenarios to cover Services.
- 2. If under Lot 3 there is a breakdown of the prices for individual elements e.g. home visit costs the prices for the individual elements The same applies to Lot 3, specifically in relation to the pricing request for individual elements. Lot 3 is a managed service of an in-centre Renal unit, based on a specific scenario. Pricing for customers will be a result of a further competition, which is bespoke to each authority dependant on their individual need. Home visit costs do not apply for this Lot.
- 3. The details of any financial penalties that can be imposed on suppliers under Lot 3, the amounts of any penalties and the description of when these can be imposed. We do not set or apply any penalties at a framework level, as these are seen as punitive measures and are not permitted under the current procurement legislation (PCR 2015 due to the timing of our Framework award). The Trusts may however, set out within their contracts, any remedial measures, if the supplier(s) does not meet the required KPI's; these will be embedded in the customer/supplier contract if applicable.

We are unable to provide further detail on the information you have requested because it is exempt under Section 43(2) of the Freedom of Information Act 2000. This section of the Act allows us to withhold information if disclosing it would prejudice the commercial interests of any person or organisation, including our own.

The information that has been requested includes details that are considered commercially sensitive since it could unfairly impact competitive Suppliers within the Renal Market.
