Pricing did not go live until November 2021 hence why the spend report starts on this date and not August 2021. SCCL are unable to provide information broken down by supplier as it is exempt from disclosure under section 43\(2\) \(Commercial Interests\) of the FOI Act 2000. This provides that information can be withheld where disclosure would, or would be likely to, prejudice the commercial interests of any person \(including the public authority holding it\).](#)

[The Minimally Invasive Surgery \(MIS\) framework is in its extension period currently and will be renewed. Tender to commence January 2025.](#)
